We have reviewed the accompanying statement of unaudited Ind AS financial results of Scan Steels Limited ('The Company') for the quarter ended 30th September 2018 and the year to date Ind AS financial results for the period from 1st April 2018 to 30th September 2018, attached herewith, being submitted by the Company pursuant to requirement of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015('the Regulation'), read with SEBI circular No.CIR/CFD/FAC/62/2016 dated July, 2016('the Circular').

These quarterly as well as year to date Ind AS financial results have been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard, Interim Financial Reporting (Ind AS 34) prescribed, under section 133 of the Companies Act, 2013 read with Rule 3 of Companies (Indian Accounting Standards) Rules, 2015, as amended, read with Circular is the responsibility of the Company's management and has been approved by the Board of Directors of the Company. Our responsibility is to express a conclusion on the statement based on our review.

Notes:

- 1 The above unaudited financial results have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on November 13, 2018. The Statutory Auditors have carried out a Limited Review of the Results for the Quarter Ended and Half Year Ended September 30,2018.
- 2 Post the applicability of Goods & Service Tax (GST) with effect from July 01, 2017, revenue from operations is disclosed net of GST.
- 3 Other Operating Income includes sale of services alongwith gain or loss from "Commodity/Equity Derivative transactions under F&O segment" of various commodities through Stock Exchange. The profit/(Loss) on the settlement date is recognised in the financial statement and the fair value of derivative instruments in hand as on the reporting date is measured at FVTOCI and shown under "Reserves for Fair Valuation of Derivative Instuments" to be reclassified to statement of profit and loss on future settlement date.
- 4 All the lenders of the Company have re-classified the loan facilities as Performing Assets on or before the date of 30th September, 2018 which were earlier classified as Non Performing Assets in the year 2015 and thereafter. As of now, all the loan facilities availed by the company have been treated as Standard Assets in the books of account of the lenders.

Further, the company has reversed back and credited to the statement of profit & loss account, the amount to the tune of INR 464.73 lakhs (out of that INR 328.70 lakhs during this quarter under review) which is waived off by the lenders under Negotiated Settlement scheme. As a result, the finance cost for the quarter ended 30th September, 2018 has been reduced by that amount.

- 5 The Company is engaged in only one segment viz. Steel Manufacturing and as such there is no separate reportable segments as per IND AS -108 "Operating Segment"
- 6 During the quarter under review, the Company have repaid all of its deposits. However, The deposits accepted from the relatives of Key Managerial Personnel have been converted into unsecured loan with an agreed interest rate.
- 7 Figures for the previous quarter/year has been regrouped and/or reclassified wherever necessary.
