कोल्हापूर मनपात दोन नगरसेवकांनी घेतले चुंबन

कोल्हापूर महापालिकेच्या सभागृहात किळसवाणा प्रकार घडला आहे. दोन पुरुष नगरसेवकांनी एकमेकांचं चुंबन घेतल्याचं दृष्य कॅमेऱ्यामध्ये कैद झाले आहे. कोल्हापूर महापालिकेची सभा सुरू असतानाच हा धक्कादायक प्रकार घडला आहे.
