As you know that, the Securities and Exchange Board of India (SEBI) has notified amendments to Regulation 40 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 vide Gazette notification dated June 8, 2018 which will come into force on 5th December, 2018.

Pursuant to these amendments, SEBI has mandated that transfer of securities would be carried out in dematerialized form only and shares held in physical form cannot be transferred to any other person unless the shares are held in dematerialized form. Accordingly, shares which are lodged for transfer shall be in dematerialized form only.
